On Saturday, March 16 and Sunday, March 17, 2019, **Cal's Angels** and **12 Oaks Sibling Assistance Program** will proudly host our **9th ANNUAL HOOPS FOR HOPE 3v3 Basketball Tournament**. This event is one of THE LARGEST basketball tournaments in Lake County. Last year, we had over 500 participants and volunteers—from fourth graders through high school players, and raised more than \$20,000.

Twelve Oaks Foundation was established in memory of Matthew Hupp by his parents, Julie and Steve Hupp. In 2018, Twelve Oaks merged with Cal's Angels, Chicagoland's premier pediatric cancer support organization. Like Cal, Matt tragically lost his battle with Burkitt's Lymphoma in 2009 at age 13. 12 Oaks Foundation has honored his legacy of leadership, discipline, perseverance, and self-confidence by providing grants to defray the cost of sports and other activities for children of families suffering temporary financial hardship related to ongoing cancer treatment. And now, 12 Oaks proudly joins Cal's Angels to continue the fight against pediatric cancer.

Last year alone, we provided grants to over 150 children in Illinois and Wisconsin of \$500 per child and up to \$2,000 per family with a total of \$55,000 in grants given. Our goal this year is to raise over \$30,000. Without our funding, these families might not have the financial ability to cover these costs. A cancer diagnosis is devastating financially and emotionally, and helping with finances is an area where we can make a difference.
